

- 3.4.2** comply with all the provisions of the Act, the Statutes and the Ordinances, Rules and Regulations of the University framed in this regard;
- 3.4.3** follow the Rules, Regulations and Guidelines of the Statutory / Regulatory bodies issued from time to time;
- 3.4.4** the effect that the number of teaching posts, the qualification of teaching staff and their recruitment / promotions procedures as prescribed by the UGC and conditions of service shall be in accordance with the Statutes / Ordinance / Regulations of the University / State Government / UGC, and shall ensure imparting of adequate instruction to the students in the courses / programmes of studies to be undertaken by the college and that the Student-Teacher Ratio the college shall be as per the UGC norms;
- 3.4.5** the effect that the members of the teaching and non-teaching staff shall be regularly and fully paid in the pay scales along with applicable allowances as per the pay scales prescribed by the UGC / Central / State Govt., as the case may be from time to time;
- 3.4.6** the effect that appointment of members of the teaching and the non-teaching staff shall be made only on considerations of merit based on qualifications and experience prescribed for them and not by demanding or accepting any donation or other consideration;
- 3.4.7** the effect that the college shall obtain the eligibility approval of the appointed teaching staff from the University within three months of affiliation and shall report all changes in the teaching staff and all other changes that may effect the fulfilment of the conditions for affiliation to the University within a fortnight of changes coming into effect;
- 3.4.8** the effect that all fees to be charged from the students shall be as per the fee structure approved by the University based on the norms of the UGC from time to time;

- 3.4.9** the effect that the college shall not collect any capitation fee or donation in any form amounting to corrupt practices from or on behalf of any of its students or their parents/guardians except the prescribed fee and other charges as approved by the University based on the norms of the UGC;
- 3.4.10** the effect that no student shall be admitted to any programme of study by the college in anticipation of grant of affiliation or in excess of the number of seats sanctioned per programme of study by the University;
- 3.4.11** the effect that the college shall not, without the previous permission of the University, suspend offering an already approved course/ programme of study;
- 3.4.12** the effect that the academic and welfare activities of the students belonging to the Scheduled Castes, Scheduled Tribes and other disadvantaged groups, including minorities, wherever applicable, shall be properly taken care of by the college,
- 3.4.13.** the effect that all registers and records, including audited statement of accounts, as required to be maintained under the Regulations / Orders of the UGC / University / Government shall be maintained and made available as and when required for inspection;
- 3.4.14** the effect that the college shall furnish all such returns and other information as the UGC / University / Government may require to enable it to monitor and judge the performance of the college with regard to maintenance of academic standards and shall take such action as the UGC / University / Government may direct to maintain the same;
- 3.4.15** the effect that after the college is affiliated, the same will not be shifted to a different location or will not be transferred to a different Society, Trust, individual or a group of individuals without the prior approval of the University;

Statutes Governing the Affiliation of Colleges/ Institutions under the jurisdiction of Kuvempu University, 2019. (Framed under Section 59 read with Sections 40(g) and 41 of the Karnataka State Universities Act 2000).

Preamble:

In exercise of the powers conferred by clauses (f) and (g) of Sub-Section (1) of Section 26 of the University Grants Commission Act, 1956, the UGC has framed Regulations 2009 for affiliation of Colleges by the Universities, by its Notifications bearing Nos. UGC No.F.1 – 7/2007 (CPP-I), Dated 29 April, 2010 and F. No. 1-7/2007 (CPP-1/C), Dated 13 February, 2012. The UGC has directed all the Universities to adopt these Regulations for affiliation of Colleges by the Universities, with immediate effect. The UGC has also made clarifications that these regulations shall apply to all those colleges which have been established or incorporated under Central Acts, Provincial Acts or State Acts, and already affiliated to the Universities in India.

1. Short Title, Application and Commencement:

- 1.1. These Statutes may be called "Statutes Governing the affiliation of Colleges/Institutions situating under the territorial jurisdiction of Kuvempu University 2019.
- 1.2. These Statutes shall apply to all those colleges seeking affiliation and already affiliated to the Kuvempu University under the Karnataka state Universities Act 2000.
- 1.3. These Statutes shall come into force with effect from the date of assent of the Chancellor.



2. . Definitions: In these Statutes;

- 2.1 "Affiliation" together with its grammatical variations, includes, in relation to a college, recognition of such college by association of such college with and admission of such college to the privileges of the University;
- 2.2 "College" means any institution, whether known as such or by any other name which provides for a program of study beyond 12 years of schooling for obtaining any qualification from the university and which, in accordance with the rules and regulations of the university, is recognized by the UGC as competent to provide such program of study and present students undergoing such program of study for the examination for the award of such qualification;
- 2.3 "Grant-in-aid College" means a college receiving grants from the Government for payment of salary of its employees;
- 2.4 "University" means Kuvempu University established under the KSU (Amendment) Act 1987.
- 2.5 "Course" means one of the units which comprises a program of study;
- 2.6 "Program of study" means a higher education program pursued for a degree specified by the Commission under Section 22(3) of the UGC Act;
- 2.7 "Statutory/Regulatory body" means a body so constituted by a Central/State Government Act for setting and maintaining standards in the relevant areas of higher education.
- 2.8 "Student" means a person admitted to and pursuing a specified program of study;

3. Eligibility Criteria for Temporary Affiliation:

3.1. The proposed college seeking affiliation, at the time of inspection by the university, shall satisfy the following requirements, or the requirements in respect of any of them prescribed by the Statutory / Regulatory body concerned, in the case of technical / professional courses only.

3.1.1 Undisputed ownership and possession of land free from any or all encumbrances measuring not less than 1.5 acres if it is located in mega cities, 2 acres if it is located in metropolitan cities, and 5 acres if it is located in other cities/ areas;

Provided that this sub-clause shall not apply to colleges already affiliated to the University prior to the date of notification of UGC (Affiliation of Colleges by Universities) Regulations 2009 and its amendments in 2012.

Provided further that the lesser land requirement in mega cities shall not compromise extracurricular/extra-mural curricular activities of the college:

Provided also that the requirement of 5 acres in hilly areas could be contiguous or up to three places which are not separated by more than 2 kilometer.

However, in case of professional programs land requirements shall be as prescribed by the respective statutory/ regulatory bodies.

3.1.2 Administrative, academic and other buildings with sufficient accommodation to meet with the immediate academic and other spaces requirements as specified in clause 3.1.3 of this statute for each of the higher education program with adequate scope for future expansion in conformity with those prescribed by the UGC / Statutory / Regulatory body concerned, taking care that all buildings constructed in the college are disabled friendly;

3.1.3 The buildings in which the college is to be located should be suitable and enough provision shall be made for the residence in the college or in lodgings approved by the college, for students not residing with their parents or guardians and for the supervision and welfare of students. The academic buildings should be sufficient to accommodate the faculties, lecture/ seminar rooms, library and laboratories with a minimum of **15 sq. ft.** per student in lecture/seminar rooms/library and **20 sq. ft.** per student in each of the laboratories;

Provided that this sub-clause shall not apply to colleges already affiliated to the University prior to the date of notification of UGC (Affiliation of Colleges by Universities) Regulations 2009 and its amendments in 2012.

3.1.4 Number of teaching and non-teaching staff and qualifications of the teaching staff and the conditions governing their tenure of office are such as to make due provision for the courses of instruction, teaching or training to be undertaken by the college;

3.1.5 Adequate civic facilities for essentials like water, electricity, ventilation, toilets, sewerage, etc. in conformity with the norms lay down by the Central/State PWD;

3.1.6 Adequate measures for safety, security, pollution control, etc.

3.1.7 A library with at least 1000 books, or 100 books in different titles on each subject, whichever is more, of the proposed programs to include both text books and reference books, besides two journals per subject, along with a book bank facility for students belonging to Scheduled Castes, Scheduled Tribes and such other sections as may be specified by the UGC from time to time,

3.1.8 In cases where affiliation is sought in any branch of experimental science, necessary laboratory equipment for imparting instruction in a properly equipped laboratory or museum, as prescribed by the University/ Statutory/ Regulatory body concerned shall be made, for each of the higher education programs;

- 3.1.9 A multi-purpose complex/ an auditorium and facilities for sports, canteen, health care, separate common rooms and separate hostels for boys and girls as per the local requirements as decided by the University;
- 3.1.10 Appropriate furniture for lecture/ seminar rooms, laboratories, library, faculty rooms, rooms for administrative staff including the Principal, multi-purpose complex/ auditorium, common rooms and hostel rooms, and for other facilities;
- 3.1.11 A duly constituted managing body as specified by the University.
- 3.2. The college, if not run by the State Government,
- 3.2.1 Shall be managed by a duly constituted and registered society or Trust;
- 3.2.2 Shall satisfy the University with adequate financial provision as available for running the college for at least three years without any aid from any external source. In particular, it shall produce evidence of creating and maintaining a Corpus Fund permanently in the name of the college by way of irrevocable Government Securities of Rs. 15 lakhs per **program**, if the college proposes to conduct program only in Arts, Science and Commerce, Rs. 35 lakh per program or so prescribed by the relevant Statutory/Regulatory body, if it proposes to offer professional programs, or FDRs for like amounts jointly held by the **college** and the **University** for a **minimum lock in period of three years**. The interest accrued out of it may be utilized by the college with the prior permission of the University for strengthening its infrastructure facilities;
- 3.2.3 Shall also provide an undertaking to the University that has adequate recurring income from its own resources for its continued and efficient functioning.

3.3 The Registered Society / Trust in justified exceptional cases may be allowed to start the college for the first year of the program in a readily available building. With the condition that all other academic and administrative requirements are satisfied under the Regulations and the college shall complete the buildings per clause 4.4.6 of this statute and other requirements cited in the detailed project report by the end of the second year and the college is moved completely to the proposed permanent building by the beginning of the third year, failing which the college shall not be granted renewal of temporary affiliation until the college moves to the permanent buildings. Under no circumstances, extension of time for this movement to the permanent building shall be granted by the University beyond five years.

3.4 The Registered Society / Trust proposing the college shall execute a bond:

3.4.1 To impart instruction only in the subjects and for the courses / programs in the faculties for which affiliation has been granted by the University and shall not seek retrospective affiliation. All such courses / programs shall follow the syllabi approved by the appropriate academic bodies of the university;

3.4.2 To comply with all the provisions of the Act, the Statutes and the Ordinances, Rules and Regulations of the University framed in this regard;

3.4.3 To follow the Rules, Regulations and Guidelines of the Statutory / Regulatory bodies issued from time to time;

3.4.4 To the effect that the number of teaching posts, the qualification of teaching staff and their recruitment / promotions procedures as prescribed by the UGC and conditions of service shall be in accordance with the Statutes / Ordinance / Regulations of the University / State Government / UGC, and shall ensure imparting of adequate instruction to the students in the courses / programs of studies to be undertaken by the college and that the Student-Teacher Ratio in the college shall be as per the UGC norms;

- 3.4.5 To the effect that the members of the teaching and non-teaching staff shall be regularly and fully paid in the pay scales along with applicable allowances as per the pay scales prescribed by the UGC / Central / State Govt., as the case may be from time to time;
- 3.4.6 To the effect that appointment of members of the teaching and the non-teaching staff shall be made only on considerations of merit based on qualifications and experience prescribed for them and not by demanding or accepting any donation or other consideration;
- 3.4.7 To the effect that the college shall obtain the eligibility approval of the appointed teaching staff from the University within three months of affiliation and shall report all changes in the teaching staff and all other changes that may affect the fulfillment of the conditions for affiliation to the University within a fortnight of changes coming into effect;
- 3.4.8 To the effect that all fees to be charged from the students shall be as per the fee structure approved by the University based on the norms of the UGC from time to time;
- 3.4.9 To the effect that the college shall not collect any capitation fee or donation in any form amounting to corrupt practices from or on behalf of any of its students or their parents/guardians except the prescribed fee and other charges as approved by the University based on the norms of the UGC;
- 3.4.10 To the effect that no student shall be admitted to any program of study by the college in anticipation of grant of affiliation or in excess of the number of seats sanctioned per program of study by the University;

- 3.4.11 To the effect that the college shall not, without the previous permission of the University, suspend offering an already approved course/ program of study;
- 3.4.12 To the effect that the academic and welfare activities of the students belonging to the Scheduled Castes, Scheduled Tribes and other disadvantaged groups, including minorities, wherever applicable, shall be properly taken care of by the college,
- 3.4.13. To the effect that all registers and records, including audited statement of accounts, as required to be maintained under the Regulations / Orders of the UGC / University / Government shall be maintained and made available as and when required for inspection;
- 3.4.14 To the effect that the college shall furnish all such returns and other information as the UGC / University / Government may require to enable it to monitor and judge the performance of the college with regard to maintenance of academic standards and shall take such action as the UGC / University / Government may direct to maintain the same;
- 3.4.15 **Transfer of management:** To the effect that after the college is affiliated, the same will not be shifted to a different location or will not be transferred to a different Society, Trust, individual or a group of individuals without the prior approval of the University;
- 3.4.16 To the effect that as far as circumstances may permit due provision shall be made for the residence of the principal and members of the teaching staff in or near the college or the place provided for the residence of students;
- 3.4.17 To the effect that the financial resources of the college are such as to make due provision for its continued maintenance and efficient working; and

4. The opening of new colleges, procedure for granting Temporary Affiliation and intake of students in the college:

4.1 Colleges within the University area shall on satisfying the conditions specified in these Statutes be affiliated to the University as affiliated colleges of the University.

4.2 The Registrar shall notify at least in two leading newspapers one in English and one in Kannada, inviting applications for affiliation of new colleges, new courses in the existing affiliated colleges, new subjects in the affiliated colleges and also variation in the sanctioned intake fixing the last date for receipt of applications. The advertisement shall also contain such other particulars as may be required by the University and also specify the amount of fee for affiliation with a specific indication where the college requires, to obtain the approval or recognition of the All India Council for Technical Education, the National Council for Teachers Education or such other authorities to that effect.

4.3 The application to start a new college and to get it affiliated to the University can be submitted by Central/ State Government institutions and Registered Society/ Registered Public Trust, financially viable to run the colleges without the aid of the State Government. Applications for affiliation of new colleges shall not be entertained from individuals.

4.4 If the applicant is a Society/ Trust, it shall have been registered under Registration of Societies Act, the Trusts Act or any other Act of the Central/ State Government on or before the date of submission of the application. It is to be under the management of a regularly constituted governing body;

- 4.5 The Government/ Society/ Trust which proposes to start the college and wishes to get it affiliated to the University in whose jurisdiction the location of college falls shall make an application within the stipulated time to the University in the prescribed printed pro-forma or through the online pro-forma, along with the prescribed fee in the form of Demand Draft drawn in favour of the Registrar of the University or through online payment, as prescribed by the University.
- 4.6 The application seeking affiliation shall be submitted to the Registrar of the university, within the time limit stipulated in the advertisement, with certified copies of the following documents:
- 4.6.1 Registration of the Society/ Trust along with details of Constitution and Memorandum of Association,
- 4.6.2 Letter from the Competent Authority designated by the Government concerned for classification of land and its location as Metropolitan or other areas,
- 4.6.3 Land Use Certificate from the Competent Authority designated by the Government concerned;
- 4.6.4 Registered land/Govt. leased land documents in the name of the applicant;
- 4.6.5 Building Plan of the proposed college prepared by a registered Architect and approved by the Competent Authority designated by the Govt. concerned;
- 4.6.6 Registered documents by the registered Society/ Trust earmarking land and buildings for the proposed college;



4.6.7 Details of the latest fund position along with photocopies of relevant bank accounts including the evidence of the Corpus Fund earmarked for the purpose as specified under Clause 3.2.2 of this statute.

4.6.8 Detailed Project Report: The project report shall also include need of the college in the locality, the type of education intended, the existing provisions for similar type of education made by other colleges/ institutions in the neighborhood and the suitability of the locality for education purpose. The Project Report shall give the following:

- a) Background of the Society / Trust with reference to its experience in promoting, managing and operating educational institutions, details of its promoters including their background; its activities in the social, charitable and educational spheres since its inception and its Vision and Mission;
- b) Development plan for the college with timeline, spelling out its growth plan over the first 10 year period in terms of phasing of academic programs, increase in students' intake and introduction of postgraduate programs / research, and the time schedule for stage-wise development of the academic infrastructure, like recruitment of faculty, and other support facilities, including student amenities, such as hostels, sports and recreational facilities;
- c) Architectural master plan indicating the land use pattern including those for the future;
- d) Policy with regard to faculty recruitment, retention and development;
- e) Structure of academic and administrative governance;
- f) Sources of financing of capital and operating expenditure, besides funds to be generated through students' fees; and
- g) Resource projections and their utilization schedule.

4.7 Formation of Local Inquiry Committee: The University shall make a preliminary scrutiny of the application, and if found satisfactory, issue a letter of intent, within two weeks from the date of receipt of the application by the university, to cause an inspection within a period of three months for physical verification of all facilities needed for affiliation. It shall be placed before the Syndicate for consideration. The Syndicate on consideration of each of the applications for affiliation shall direct a local inquiry to be made by a Local Inquiry Committee: Provided that the local inquiry committee shall consist of at least one person belonging to the Scheduled Castes or the Scheduled Tribes. The Local Inquiry Committee shall within thirty days from the date of constitution thereof submit a report to the Academic Council.

4.8 Expert Committee for Inspection: The college shall be subjected to an inspection by the Local Inquiry Committee of the University, consisting of experts nominated by the Syndicate:

4.8.1 One Expert for each of the subject areas/ faculties proposed,

4.8.2 Director-College Development Council/ an equivalent academician of the University,

4.8.3 A representative of the higher education department of the Government not below the rank of Deputy Director, and

4.8.4 An Engineer from the PWD/ CPWD or the University not below the rank of Executive Engineer.

4.8.5 One of the subject experts at the level of Professor, as nominated by the Vice-Chancellor, shall be the Chairperson of the Committee.

If any of the above members of the expert committee does not belong to SC/ST categories, then an academician representing these categories be nominated.

- 4.9 The report of the inspection committee shall be submitted by the Chairperson to the University duly filled in and signed by all the members. The University shall process the report through its appropriated Bodies and decide to grant, or not to grant, temporary affiliation to the college, recording the reasons in writing for its decision within three months of inspection.
- 4.10 The Academic Council shall soon after the receipt of the report of the Local Inquiry Committee consider the findings of the Committee envisaged in the report and make such further enquiry as may appear it to be necessary and record its opinion on such request and transmit it to the Syndicate.
- 4.11 The Syndicate shall consider the report of the Committee and the resolution of the Academic Council and shall further record its opinion on the question whether the request shall be granted either in whole or in part or rejected, after making such further enquiry as may be deemed necessary.
- 4.12 On the basis of the infrastructure and other facilities available at the college, the University shall decide the number of seats for each program in the college.
- 4.13 The Syndicate / Executive Council of the University shall be the authority to decide granting, or not granting, affiliation, subject to the approval from the Government permitting the Society / Trust to start the college with details of the courses / programs intended to be offered;
- 4.14 The Registrar shall submit the application and its enclosures, annexures, the report of the Local Inquiry Committee, and the proceedings of the Academic Council and Syndicate to the State Government for approval before 31st March of ensuing year.

4.15 The University shall on receipt of the approval or otherwise of the State Government issue formal orders accordingly. The University shall specify in the order, the course of study in respect of which and the period for which the college or course is affiliated with the specified intake with or without specific conditions.

4.16 Sanction of affiliation however, be subject to obtaining the prior approval of the All India Council for Technical Education, the National Council for Teacher Education, or such other authorities or bodies concerned by the College, wherever required and the intake determined shall not exceed the intake if any specified by such authorities or bodies.

4.17 Continuation of affiliation:

Continuation of temporary affiliation of the program of study and the college itself shall be granted by the University on a year to year basis through inspection process prescribed in these statutes.

4.18 If the University decides not to grant affiliation to the college for reasons, recorded in writing, of its failure to meet the conditions / requirements for getting affiliation, the college may apply again if it fulfils the conditions / requirements subsequently, but not earlier than six months from the date of rejection of its earlier application.

4.19 Any application made for grant of affiliation etc. may be withdrawn by the applicant at any time before an order is made under sub-section 4.15.

4.20 Renewal of affiliation or continuation of affiliation for each academic year for the existing courses of study and extension of affiliation for follow on courses, excluding new courses, may be granted by the Syndicate in consultation with the Academic Council in the same manner as applicable for grant of fresh affiliation.

4.21 The intake in respect of each of the courses of study shall be determined on an yearly basis by the University well before the commencement of each academic year in the order granting affiliation or continuation of affiliation, as the case may be

Provided that in case of professional courses like Engineering, Architecture and Management including Post-Graduate Programs in the affiliated colleges, the intake shall be fixed with the approval of the State Government.

4.22 The admission of students shall not be made by a new college seeking affiliation to any University or by an existing college seeking affiliation to a new course of study or in excess of the stipulated intake, unless, as the case may be affiliation has been granted by the University to a new college or to a new course in the existing affiliated college in respect of such a course of study or for variation of the stipulated intake.

4.23 Action shall be taken against any Institution contravening the provisions of sub-section 4.22 in accordance with the provisions of the Karnataka Prohibition of Admissions of Students to Un-recognized and Un-Affiliated Educational Institutions Act, 1992 (Karnataka Act 7 of 1993).

5. Permanent affiliation: Eligibility Criteria

5.1 A College which was affiliated continuously for a period of not less than five years and fulfilled all the conditions of affiliation and attained the academic excellence and the administrative standards as prescribed by the University/ UGC/ Statutory/ Regulatory Body concerned from time to time shall be eligible for grant of permanent affiliation.

5.2 The above provisions of these Statutes shall mutatis mutandis apply for sanction of permanent affiliation.

- 5.3 The college shall have completed construction of buildings and all infrastructure/facilities as stipulated in the Regulations;
- 5.4 All the teaching and non-teaching staff are appointed on permanent (appointed on regular basis, in case of a Government college) on the UGC/ Government scales of pay,
- 5.5 The college shall have a duly constituted College Council as per the norms.
- 5.6 The college shall be accredited by NAAC or any other statutory accreditation agency by State / Central Government.

6. Procedure for granting Permanent Affiliation

- 6.1 A College which wishes to get permanent affiliation shall apply to the University any time after completing five years of temporary affiliation in the pro-forma along with the prescribed fee in the form of Demand draft drawn in favour of the Registrar / Finance Officer of the University
- 6.2 The procedure for according permanent affiliation shall be the same as for granting temporary affiliation given in the statutes.
- 6.3 If the University decides not to grant permanent affiliation to the college for the reasons, to be recorded in writing, of its failure to meet the conditions / requirements for getting such affiliation, the college may apply again if it fulfils the conditions / requirements subsequently, but not earlier than six months from the date of rejection of its earlier application.
- 6.4 A College permanently affiliated to the University shall be subject to review of its functioning both administratively and academically from time to time by the University and the State Government, at least once in a period of five years.

6.5 Notwithstanding anything contained in the preceding sub-sections if a permanently affiliated college fails to fulfil any of the conditions specified in sub-section(5), the permanent affiliation shall be revoked:

6.6 Provided that permanent affiliation shall not be revoked unless an opportunity is afforded by the University, to the college concerned:

6.7 Provided further that on revocation of the permanent affiliation, the concerned college shall seek temporary continuation of affiliation on yearly basis.

7. Eligibility to apply for change or addition of new programs / subjects of study:

7.1 Any proposal for adding new programs shall be considered by the University only after ensuring equitable distribution of facilities for higher education, having due regard, in particular, to the needs of the un-served, underdeveloped, rural, hilly, tribal and backward areas within its jurisdiction.

7.2 Any proposal for raising the existing under-graduate college to post graduate studies level shall be considered by the University only after satisfactory completion of two years of the under-graduate program and the proposed buildings, qualified faculty and other infrastructure facilities are fully created as per the statutes.


7.3 Each application for addition of a new program or for upgrading the existing program to post graduate level shall be accompanied by the prescribed fee in the form of Demand drafts drawn in favour of the Registrar / Finance Officer of the University.

7.4 The procedure for according temporary affiliation to additional programs of study or for upgrading the existing programs in the college shall be the same as prescribed under the statutes for temporary affiliation

8. Withdrawal of Affiliation:

- 8.1 The privileges/rights conferred on a college by affiliation, either temporary or permanent may be withdrawn in part or in full, suspended or modified, if the college on due enquiry, is found to have failed to comply with any of the provisions of the Act, the Statutes, the Ordinances, the Rules and Regulations or any other direction or instruction of the UGC / University / Statutory / Regulatory body concerned, or failed to observe any of the conditions of affiliation, or has conducted itself in a manner prejudicial to the academic and administrative standards and interests of the education/University.
- 8.2 If an affiliated college ceases to function or is shifted to a different location or is transferred to a different Society, Trust, individual or a group of individuals without the prior approval of the University, the affiliation granted to the college shall lapse automatically on such cease, shifting or transfer, as the case may be, and it shall be treated as a new college for the purposes of future affiliation. The University/Government shall have the duty to alleviate the educational future of the affected students in an appropriate manner as per its decision.
- 8.3 Without prejudice to its regulations, the UGC on its own, or on the basis of any complaint or any other information or report from any other source, can cause an enquiry by the University in respect of a college, and after giving the college a reasonable opportunity of being heard, may pass an order under Section (12A) (4) of the UGC Act prohibiting such college from presenting any student then undergoing such specified course / program of study therein to an university for the award of the qualification concerned and the affiliation of the college shall stand terminated as per Section (12A) (5) of the UCC Act.

8.4 If the University decides to withdraw the affiliation of the college, or the affiliation stands terminated by the order of the University, temporarily or permanently, such decision shall not affect the interests of the students of the college who were on its rolls at the time of issue of the order till they pass out the normal duration of programs to which they are registered at that time. The University/Government shall have the duty to alleviate the educational future of the affected students in an appropriate manner as per its decision.

9. Procedure for Withdrawal of Affiliation:

9.1 A motion for the withdrawal or the modification of such rights shall be initiated only in the Syndicate. Any member of the Syndicate, including ex-officio member who intends to move such a motion shall give a notice of it in writing setting out the grounds on which such a motion is made.

9.2 Before taking the said motion into consideration, the Syndicate shall send a copy of the said notice to the principal of the college concerned specifically intimating that any representation in writing on the motion shall be submitted by the college within a period to be specified in such intimation and the same will be considered by the Syndicate.

9.3 The period so specified in sub-clause (8.4) may if so expedient be extended by the Syndicate up to a reasonable time.

9.4 On receipt of the representation or on the expiry of the period referred to in the preceding sub-sections, the Syndicate after considering the notice of motion, the grounds set out therein and the representation received thereon and after such inspection by a Committee constituted and authorized by it in this behalf and after such further enquiry as may appear to it to be necessary pass a resolution regarding the reasons there for and shall transmit it to the Academic Council.

- 9.5 On receipt of the report under sub-clause (9.2), the Academic Council shall, after such further enquiry, if any, as may appear to it to be necessary, record its opinion and refer back to the Syndicate.
- 9.6 The Syndicate after considering the resolution of the Academic Council, shall pass a final resolution recommending the withdrawal of affiliation. Such a resolution shall not be deemed to have been passed by the Syndicate unless it has obtained the support of two thirds of the members present at a meeting.
- 9.7 The Registrar shall submit the proposal with all the documents including the notice of motion, the reply of the college, resolutions of the Syndicate and the Academic Council to the State Government for approval.
- 9.8 The University shall on receipt of approval pass formal order to withdraw the affiliation in whole or in part, as applicable from a particular academic year or to reject the proposal.
- 9.9 The students of a college, the affiliation of which has been withdrawn in whole or in part shall be accommodated in the nearby colleges by the University by increasing the intake in respect of particular course of study to the extent of such students to be accommodated. All the documents in respect of such students shall be transferred from the college in respect of which the affiliation has been withdrawn to the college to which they are transferred by the University.

10. Voluntary closure of college or course

- 10.1 The management of any college which intends to close down the college or a course in view of its incapacity or financial viability or breakdown of the management, shall give a notice in writing of not less than three months prior to the intended closure of the college to the University and to the State Government, stating the reasons therefore.

10.2 The application for closure of the college or a course shall be considered by the Academic Council and the Syndicate and pass appropriate resolutions thereon.

10.3 The Registrar shall transmit the application and the resolutions of the Academic Council and the Syndicate to the Government which shall on consideration of the same issue directions either to permit the closure or to reject the closure to the University and the University shall on receipt of such directions pass orders accordingly.

10.4 The management shall not close down the college or a course during the currency of the academic year, and until the annual examinations conducted by the University in respect of the course of study are over and a formal order has been issued by the University to do so.

10.5 The students of such closed colleges shall on transfer be accommodated in the nearby colleges by the University by increasing the intake in respect of particular course of study to the extent of such students to be accommodated from such closed college and all documents in respect of each student shall be transmitted to the college in which such students are admitted.

10.6. If within ninety days after the expiry of the term of notice under sub-clause 10.1, the State Government does not issue any direction either permitting or rejecting the closure it shall be deemed subject to the provisions of sub-clause 10.4, that the management is permitted to close the college or the course as the case may be.

11. Inspection of Colleges.

11.1 Every affiliated college including permanently affiliated college shall furnish to the Registrar such reports, returns and other information as the Syndicate in consultation with Academic Council may require to judge the efficiency of the college and the academic quality achieved.

11.2 The Syndicate shall cause every such college to be inspected from time to time by a committee constituted for the purpose,

11.3 The Syndicate may call upon any college so inspected to take within a specified period such action as may appear to it to be necessary in respect of any matters.

11.4 Every college shall comply with the directions of the University issued from time to time in respect of all matters relating to academic and administrative and matters ancillary thereto.

12. Penalties to Colleges which do not comply with these Statutes/ UGC Regulations:

12.1 If any college included under section 2(f) and receiving UGC Grants under section 12(8) is found guilty of violation of these statutes based on UGC Regulations, the UGC may take such action as it may deem fit, including that of withholding the grants to the college and/or delisting the said college from the list of colleges maintained by the UGC under Sections 2(f) and/or 12(B) of the UGC Act.

12.2 If any University grants affiliation to a college which does not fulfill the conditions/ requirements for affiliation as per the Regulations, or if the University grants affiliation in contravention of the relevant provisions of the UGC Act and Regulations, the UGC may take such action as it may deem fit, including that of withholding the grants to the University and/ or delisting the said University from the list of universities maintained by the UGC under Section 12B of the UGC Act.

POWER TO REMOVE DIFFICULTIES

- i) If any difficulty arises in giving effect to the provisions of these Statutes, the Vice-Chancellor may by order make such provisions not inconsistent with the Act, Statutes, Ordinances or other Regulations, as appears to be necessary or expedient to remove the difficulty.
- ii) Every order made under this rule shall be subject to ratification by the Appropriate University Authorities.

MODIFICATION OF THE STATUTE:

Notwithstanding the foregoing, the directions/amendments issued by the UGC and the orders of the Government of Karnataka issued from time to time shall be deemed to have been incorporated into this Statute and shall constitute an integral part of this Statute.
